## SEMI- ANNUAL REVIEW OF THE FTSE4GOOD INDICES

MARCH 2007

---

**This paper provides the details of the March 2007 FTSE4Good Semi-Annual index review. The FTSE4Good Policy Committee has approved all constituent changes.**

### 1. INCLUSIONS

As a result of the review, a total of 25 companies are new entrants to the FTSE4Good Index Series. The table below shows the nationality of these companies (see Appendix 1 for names and sectors).

### 2. DELETIONS (REMOVALS FROM THE INDEX)

Resulting from this review, there were 17 deletions from the FTSE4Good Index Series. Of these, 12 were deleted due to failing to meet the Environmental Criteria; two were deleted for failing to meet the Supply Chain Labour Standards; two were deleted for failing to meet the Countering Bribery Criteria and one was deleted due to ownership of a company that develops weapons systems and strategic parts for nuclear weapons (see sections 2.1, 2.2, 2.3, and 2.4 respectively, for details). Appendix 2 lists all the deleted companies.

The FTSE4Good inclusion criteria evolve over time, demanding continued improvement in corporate responsibility practices in order to gain or maintain inclusion in the index. FTSE's in-house Responsible Investment Unit undertakes an extensive global engagement program with all FTSE4Good companies affected by new criteria requirements. Companies are made aware of the deadlines and what steps they have to take. ## **2.1 Companies Not Meeting the Environmental Criteria**

In May 2002, the FTSE4Good Policy Committee approved changes to strengthen the FTSE4Good environmental criteria by introducing new requirements for *all* companies in the index (e.g. beyond “high impact” companies to include “medium” and “low” impact companies as well).

At this review, the following 12 companies have failed to meet the relevant FTSE4Good environmental criteria requirements and have therefore been deleted from the index series.

## **2.2 Companies Not Meeting the Supply Chain Labour Standards Criteria**

In September 2004, the FTSE4Good Policy Committee approved changes to strengthen the FTSE4Good stakeholder relations criteria by introducing new requirements for supply chain labour standards.

At this review, the following 2 companies have failed to meet the relevant FTSE4Good supply chain labour standards criteria requirements and have therefore been deleted from the index series.

## **2.3 Companies Not Meeting the Countering Bribery Criteria**

In February 2006, the FTSE4Good Policy Committee approved changes to strengthen the FTSE4Good stakeholder relations criteria by introducing new requirements for countering bribery.

At this review, the following 2 companies have failed to meet the relevant FTSE4Good countering bribery criteria requirements and have therefore been deleted from the index series.

## **2.4 Companies Deleted For Activities in Excluded Sectors**

At this review one company, *Alcatel-Lucent*, was identified as having acquired a at least a 20% stake in a company involved in the development of weapons systems and strategic parts for nuclear weapons and has therefore been deleted from the index series.
